	5.	FIRE FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

- In Case of Emergency : Isolate and post spill area. Wear cotton overalls buttoned to the neck and wrist, washable hat, elbowlength PVC gloves and eye/face protection to prevent skin and eyes being affected. Evacuate unprotected and unnecessary personnel from area of spill. If material is leaking from a container, stop the leak only if this can be done safely. Prevent spillage entering drains or watercourses. Contain spill and absorb spilled material with absorbent material such as sand, clay or cat litter and dispose of waste as per regulations.
- **Clean up Procedures** : To decontaminate spill area, tools and equipment, wash with detergent and water and add the solution to the drums of wastes already collected and label contents. Do NOT allow spilled product or wash solution to enter sewers, drains, dams, creeks or any other waterways.



7. HANDLING AND STORAGE Handling Ensure containers are kept closed until using product. Avoid contact with eyes and skin.
